CANNABIS EVENT ORGANIZER

At least one event organizer must be a licensed patient with a VALID id and a 329 card.

CANNABIS SALES ARE FORBIDDEN

No one may sell Cannabis or Cannabis products.
Only the medical use of Cannabis as defined in Hawaii State law will be allowed in a designated area.

MEDICAL USE OF CANNABIS - HRS §329-121

"Medical use" means the acquisition, possession, cultivation, use, distribution, or transportation of cannabis or paraphernalia relating to the administration of cannabis to alleviate the symptoms or effects of a qualifying patient's debilitating medical condition; provided that "medical use" does not include the cultivation or distribution of cannabis or paraphernalia by a qualifying out-of-state patient or the caregiver of a qualifying out-of-state patient. For the purposes of "medical use", the term "distribution" is limited to the transfer of cannabis and paraphernalia.

Access to the area where the medical use of Cannabis is allowed is restricted to persons 21 years of age or older.

VIP Lounge Guests are required to show a valid state ID AND a valid 329 card to access VIP Lounge.

The medical use of Cannabis at and during the event is limited to licensed patients with a valid ID and 329 card and only while inside designated areas. Cannabis consumption in this area is blocked from public view and your attendance of this event requires that you stay inside this area and out of public view while engaging in the medical use of Cannabis.

Licensees engaging in the medical use of Cannabis in the designated area are required to self-identify as a patient when requested by event staff or law enforcement.

FRIENDLY REMINDERS

In-State & Out of State Registered patients and caregivers are prohibited from acquiring, possessing, cultivating, using, distributing or transporting cannabis or paraphernalia in ALL public places.

HAWAII PATIENT POSSESSION LIMITS

Four ounces of usable marijuana at any given time, jointly possessed between the qualifying patient and the primary caregiver. "Usable marijuana" does not include the seeds, stalks, and roots of the plant.

PLEASE BE RESPONSIBLE. IT'S NOT OKAY TO DRIVE A MOTOR VEHICLE WHEN UNDER THE INFLUENCE OF MEDICAL CANNABIS. IF YOU ARE IN DOUBT, DON'T GO OUT. ASK A STAFF MEMBER FOR HELP.
